

6 Pursuant to 18 C.F.R. § 4.84, Public Utility District No. 1 of Snohomish County,
7 Washington, respectfully petitions the Federal Energy Regulatory Commission to accept
8 voluntary surrender of the preliminary permit for the Agate Passage Tidal Energy Project,
9 Project No. 12691. The preliminary permit was issued on February 22, 2007, and would have
10 expired on January 31, 2010.¹ The project would have been located underwater in a section of
11 Agate Passage in Puget Sound, between the northern end of Bainbridge Island and the Kitsap
12 Peninsula in Kitsap County, Washington.
